Coastlines around the world are being subjected to increased pressure from multiple fronts: commercial tourist interests are working to privatize beaches, while governments and other entities are looking to exploit the coasts for aquaculture, desalination plants, and energy and transportation hubs. Meanwhile, sea levels

continue to rise as a result of climate change, endangering more communities and threatening coastal habitats. In this panel, we will discuss efforts to protect the coastline from over-development and privatization within two different legal systems: in Morocco and Israel. Both Israel and Morocco are working to establish a coordinated framework for marine and coastal zone management and both countries are parties to the Barcelona Convention and the Madrid Protocol on Integrated Coastal Zone Management. We will use case studies of a country-wide aquaculture plan in Morocco and private developments in Israel to examine the balance needed between human use of the ocean and marine environmental protection, and between private interests and public natural resource rights.
